

Official Rules for 2025 Cloudflare Customer Awards

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

VOID WHERE PROHIBITED BY LAW.

1. SPONSOR

Cloudflare Inc., 101 Townsend Street, San Francisco, CA, is the Sponsor of the Cloudflare Customer Awards

2. ENTRY PERIOD

Entries must be initiated on or between May 15 and July 11, 2025. All entries and/or entry drafts and entry intentions must be received and/or confirmed by 11:59 PM Pacific Daylight Time (PDT) on July 11 to be eligible. Entries received after the Entry Period will be declared invalid.

3. ELIGIBILITY

The Cloudflare® Customer Awards are open to Cloudflare customers who have deployed, or are in the process of deploying Cloudflare products, solutions and/or technologies. Customers may be nominated for the Cloudflare Customer Awards by Cloudflare employees, by themselves and/or by a third party. All entries must be submitted online at www.cloudflarecustomerawards.cloudflare.com.

All Nominees must have expressed written or verbal consent to be submitted for the Cloudflare Customer Awards. Nominees must use Cloudflare products in their IT infrastructure and/or environment on or before the Judging Period opens. The Cloudflare Customer Awards are not open to employees, directors, officers, representatives or agents of Cloudflare and its related affiliates and subsidiaries. Customers who have existing or previous marketing sponsorship agreements with Cloudflare are not representatives or agents of Cloudflare for this purpose and are not excluded from participating in the Cloudflare Customer Awards program. Government and state employees must receive explicit approval to participate from their legal organizations to accept their prize should they be invited to participate and selected as a finalist.

To participate and qualify for the Cloudflare Customer Awards, a customer may be nominated for the Cloudflare Customer Awards by themselves and/or by Cloudflare partners and/or Cloudflare employees on Cloudflare customers' behalf. All entries must be submitted to the Cloudflare Customer Awards office via the Cloudflare Customer Awards nomination site at: <https://www.cloudflare.com/customerawards-2025/>.

Nominating Partners are responsible for obtaining their Nominees' expressed written consent in order to be submitted for the Cloudflare Customer Awards program.

Nominees must have Cloudflare products in production use in their IT infrastructure and/or environment on or before the Judging Period begins. At least one senior (Director/Head of or higher) representative must be available to participate at the Cloudflare Customer Awards Program

Celebration, to be held at Cloudflare Connect Las Vegas in the Aria Hotel, October 13 - October 16, 2025.

The Nominee's representatives must provide consent and be willing and authorized to approve a summary of the awarded project when or if the Nominee is selected as a "Finalist" or a "Winner." Marketing collateral includes but is not limited to the award ceremony presentation material, digital, web and social spotlights showcasing the project for which the "Finalist" or "Winner" is being honored. Finalists and Winners must also consent to the use of their respective company names and logos in marketing collateral as award winners. Marketing collateral will be promoted through Cloudflare social media channels and Cloudflare web properties. Finalists and Winners shall have an opportunity to review and approve marketing collateral prior to publication. Nominees and Nominating Partners that participate in the Cloudflare Customer Awards certify that their participation and receipt of the prizes do not violate any of their respective company policies. Prior to the judging period, all nominations will be reviewed by the Cloudflare Customer Awards Program Office for completeness and to ensure that the nominations meet the eligibility criteria for the 2025 Cloudflare Customer Awards.

4. DETERMINATION AND NOTIFICATION OF CATEGORY FINALISTS & WINNER

Nominees can be entered in up to two (2) of the following four (5) categories: Cloudflare Visionary Award, Cloudflare Connect Award, Cloudflare Protect Award, Cloudflare Build Award, and Cloudflare Impact Award. All of the nominations will be scored on a scale of 1-20 by the designated Cloudflare Customer Award Judging Panel, composed of at least five (5) Cloudflare employees and subject matter experts per category. The Cloudflare Customer Award Judging Panel will select one (1) winner and two (2) Finalists per category based on the cumulative scores received by the nominees from all of the judges assigned to a particular panel. Upon determination of the ten plus (10) Category Finalists and five (5) Category Winners, all will be featured on our website: www.cloudflare.com.

5. PRIZES

The category Winner(s) will be presented with a first-place trophy and Finalists will be presented with Cloudflare-branded merchandise. Both category Finalists and Winners will be celebrated at Cloudflare Connect Las Vegas. The Winner(s) will receive one (1) trophy each for their respective companies (approximately \$300.00 USD each). Both category Winners and Finalists will receive (1) complimentary pass per company to attend the Cloudflare Connect Vegas conference taking place October 13 - 16, 2025 at the Aria Resort and Casino, Las Vegas.

6. TERMS AND CONDITIONS

The Cloudflare Customer Awards are governed by these Official Rules. By participating in the Cloudflare Customer Awards Nominees and Nominating Partners fully and unconditionally agree to be bound by the terms of these Official Rules and understand that the Cloudflare Customer Awards results are final in all respects. Nominees and Nominating Partners agree that all decisions

regarding the Cloudflare Customer Awards, including but not limited to the selection of the winners, will be made by Cloudflare whose decisions shall be final and binding.

This contest is void where prohibited by law or a Nominee's corporate policies. Prizes are not transferrable. Cloudflare will not replace any lost or stolen prize; the prize is offered and must be accepted "as is" without warranty of any kind. The approximate retail values are subject to change based on current market conditions at the time of prize fulfillment. Finalists are not entitled to any surplus between actual retail value (ARV) of prize and stated ARV and any difference between stated ARV and actual value of the prize will not be awarded.
